Termination of support may only be declared from 1 April of a calendar year for the following calendar year. A refund of part of the amount already paid in the current calendar year is not possible.

**Applies only to contributions of 1,000 EUR or more per year:**

- **Press relations:** At the start of your sponsorship, the museum can, upon request, draft and issue a press release; you may also publicise the commencement of your sponsorship.
- **Website and publications:** Upon request, the museum may feature your name or your company logo on its website as well as in new (online) publications; however, for tax reasons, it is unfortunately not possible to include a hyperlink from your name or logo to your website or that of your company. You may, however, present yourself or your company on your website as a "supporting company of the Computerspielemuseum" or a "supporter of the Computerspielemuseum". For tax reasons, linking the museum's logo to your website or your company's website, or including it in (online) publications, is not permitted.
- **Social media:** The museum will introduce you or your company as a patron of the museum via its social media channels with a dedicated post – or, if you wish, a short interview – and may report on special activities organised as part of your support in an appropriate, non-promotional manner. Similarly, you or your company may report on the start of your support or specific activities via your own social media channels in an appropriate, non-promotional manner.
- **Coordination:** Both parties will jointly agree on the texts and images for press releases, web content, posts and publications before they are published.
